Dave motioned, John seconded - Meeting Opened 7:30PM

Randy Desmarais – Took and passed installer's test – Installer's permit #042704-1 issued.

John and Lisa Rehm – 36 Williams Road (Formerly Dunn Residence) new construction on old lot. New house will conform to existing footprint. Septic is a tight tank. Came in to have procedure sheet signed.

Dan Flynn – Flycon Construction – 119 Stafford Road – Well permit issued Permit #042704-2 issued.

Mr. Malinosky – 3 Wall Street came in for copy of existing septic plan.

David Trudeau – 44 Sandy Beach Road – R36-J-5,6,7 Riverview Assoc (Strawberry Fields Check) Septic plan approval and well permit. Well permit #042704-3 issued.

David Trudeau – Map R12-B-42,44,45 Joanie Dr. (Marin Realty (Strawberry Fields Check)) Septic plan approval and well permit. Well permit #042704-4 issued.
