Call to Order:

Mr. Gillen called the meeting to order at 7:00 pm.

Approval of Minutes

Motion 020617-1 Mr. Mandell, to waive reading of minutes Dec. 20th, 2016 and February 1, 2017 and approve as written. 2nd Ms. Schmidt. So voted.

Old Business:

Hampshire Power – Discussion.

Motion 020617-2 Ms. Schmidt, To accept the 36 month rate of 9.85 cents per kWh beginning March 1, 2017 to February 28, 2020. 2nd Mr. Mandell. So voted **Motion 020617-3 Mr. Mandell,** for Ms. Schmidt to sign Hampshire Power contract for electrical supply. 2nd Mr. Gillen. So voted.

Driveway permit for 65 Morse Road.

After inspection of document it was noted that the Highway Surveyor had not signed off on the permit. As the Board is not qualified to determine if the plans are appropriate, it was determined not to sign the driveway permit until the Highway Surveyor has signed it.
