Progress on:

- 1. removal of surplus vehicles no update
- 2. removal of buildings on town owned land 16 Island Road property and Circle H Ms. Schmidt will speak with the Fire Chief in regard to this.
- Options for housing police vehicles Ms. Robbins stated that she is still waiting for quotes from different sellers of Quonset huts. Quonset huts appear to be a viable option for safely housing the police fleet. There is a considerable investment in police vehicles that needs to be protected. Also the building safety is questionable for our officers using the building.
 Ms. Robbins will continue to seek information on replacing the housing for the vehicles.

New Business

Annual formula grant for Council on Aging signed by Ms. Schmidt. The grant is for \$5,000.00 that supplements the funding the Council on Aging budget. This is the standard Commonwealth contract whenever a grant is received.

SAN loan- The Green Community Grant is a reimbursement grant. The loan covers the costs until reimbursement from the Commonwealth is provided.

Motion 013018-3 Mr. Gillen to sign the SAN loan. 2nd Mr. Mandell. So voted. All board members signed loan documents.

Snow and Ice deficit – Select Board received a letter from the Highway department that the snow and ice account is now in deficit.

Motion 013018-4 Mr. Gillen, to allow deficit spending for snow and ice removal. 2nd Mr. Mandell. So voted.

CDBG tri community grant is read for submission by PVPC. A public hearing will be held next Tuesday in Wales for the grant application. Permission from the applying towns need to be signed. Because the Select Board voted to join the grant at a previous meeting no discussion or vote is necessary to sign the documents provided by Mr. Dunphy.
