Minutes of Holland Conservation Commission (HCC) held on Aug 25, 2015.

Meeting called to order at 7:00 by Chairperson Marcia Beal.

Motion by C. McCooe to waive reading of minutes of August 11, 2015 and accept with amendments. 2nd by F. Gallo. All in favor. Motion passed.

Order of business: Announcements

- HCC can now file DEP forms through the internet at https://edep.dep.mass.gov. F. Gallo worked with Mark Stinson and Judith Schmitz from DEP to set up electronic submission.
- ☑ C. McCooe reported the Lake Oversight Committee contract for the lake weed treatment contract expires in 2017.
- M. Beal suggested each board member work on a specific case from start to finish, so as to learn the whole process. C. McCooe will continue with 30 Stoney Hill Rd. (C. Henchey) (R35/C/12 DEP184-0296) and J. Crowley will work with 26 Old Acres Rd. (M. Wells) (R23/B/5).
- W. Lundin reported she noticed a tree service cutting limbs off a tree at 6 White Lane (R07/B/3) within the buffer zone. She met the owner, Mr. Joseph Pucci and asked if he had a permit. He did not have one. V. Lundin asked him to stop and not cut the tree down until he obtained a permit and came to the next HCC meeting on Tuesday, Aug 25.
- M Agricultural Exemption concerning tree removal was discussed. More information forthcoming.

New Business:

- Per C. McCooe: It is the responsibility of HCC to send a letter to the BOS (Board of Selectmen) for draw-down approval and for weed treatments. A letter will be sent to BOS for the upcoming draw down. A letter will also be sent to request an extension for weed treatment in late August and September. DEP file #129 for Draw Down and Weed Treatment Contracts of 2013 have been extended and are valid until 2017. Letters need to be sent to BOS every September for draw down.
 - o A letter to the BOS concerning this falls draw down will be written by C. McCooe

Old Business:

- A. Cormier (contractor for C. Henchey) contacted C. McCooe concerning the Enforcement Order for 30 Stoney Hill Rd. (R35/C/12). Glenn Kievosky, a certified erosion specialist, has been obtained and a plan established to divert water by installing flexible piping that would alleviate water run off from the road. The plan would be put into effect immediately to stabilize the area. C. McCooe obtained a copy and spoke with Mark Stinson who agreed the plan sounded solid. Discussion by HCC with concerns including:
 - a) What date is referred to as immediately?
 - b) How is it determined and how do you define stabilize? What is the criteria?
 - c) Who "certifies" and signs off on the plan when it has been completed?

Concerning the well & septic: C. McCooe contacted the BOH on 6/23/15. BOH replied and reported they had contacted the contractor and was waiting for a reply concerning fees, however, BOH had no reply from contractor. A. Cormier stated to HCC at the meeting of July 14, 2015 he was still waiting for BOH to issue a permit, in fact, he had not responded back to BOH as stated above.

- ☑ Dan Fetko: 35 Lakeridge Dr. (R04/A/12) F. Gallo is working with D. Fetko to help him complete his NOI. Gallo has spoken to Mark Stinson from the DEP. Stinson recommended an erosion specialist be hired. D. Fetko has hired Glenn Kievosky, erosion specialist, to submit an erosion control plan for property. Per Gallo, Stinston from DEP has been updated. The HCC will be notified as soon as plan is available.
- Timothy Martin: 29 Pine Tree Dr. (R41/B/14)
 Site visit was completed. M. Beal checked with Building Inspector. if a permit was requested/issued. J. Keough believes there was not. HCC will send a letter asking T. Martin to attend the next meeting to explain his intentions and to stop work on the wall.

Paul & Carol Mangiafico: Island Rd. (R10/C/2) 20393/385 (lot listed as land – no number at this time) Requested a building permit to build a home on the site where the original home (collapsed due to weather) had stood. Building Dept. issued a number: 1616. The new home would be built on the original foot-print with a second floor included. A Notice of

Intent must be submitted, house will be at least 30' back from water. An engineered plot plan by a certified engineering company must be submitted to the Zoning Board of Appeals. They will also be requesting permission for a septic system to be dug on lot (R10-A-29) 20358/154 (which they own) that will be beyond 100' from water front. This property is located across the street from the main property where the house will be built.

7:45 PM

Michael Wells: 26 Old Acres Rd. (R23/B/5)

Request to replace an existing retaining 70' long cement block wall (will be built approximately 5'-9' above the required 3' above water level — no building permit required) that is starting to collapse, and add a patio on the level area on top of it. New retaining wall will be about 16" to 20" high. All displaced soil will be hidden behind wall and not removed from site. Mr. Wells will submit a Notice of Intent and return with a DEP number to the next HCC meeting. Additional work: remove an old wood dock; a well house; shed (repair or replace); removal of some trees pushing on the wall. A public hearing will be scheduled and letters sent to abutters: work is within 300' of neighboring properties. Advised to contact the assessor's office to verify abutters list. Abutters must be notified and a public hearing time will be scheduled for 9/22 at 7:30 pm. Fees were paid, \$40 for ad, \$67.50 for NOI.

8:10 PM

Ron Leighton 32 Stoney Hill Rd. (R35/C/11) and Rob Say 36 Stoney Hill Rd. (R35/C/10): Abutters following up on work being done on 30 Stoney Hill Rd. (C. Henchey property). HCC informed them an Enforcement Order was issued and a certified erosion specialist has been hired. A plan is in place to control the erosion. HCC will conduct other site visits to ensure all conditions are being met and when they are, the certified erosion specialist will do the final sign off. After draw down sediment removal from lake bottom will be done. Mark Farrell-Green Hill Engineering-has been hired for the sediment removal. Also, neighbors noticed the well has been dug.

Ray Boire: 8 Shore Lane (R01/A/10)

He received a permit for a well, contracted Charlton Well to dig the well (about 25' from the water). He (or Charlton Well) must complete a Notice of Intent for the well and return to HCC when DEP number is received. BOH approved for a 2 bedroom septic.

Representing Jeff Covell, owner of 18 Butterworth Rd. (R5/C/1/3). Owner wishes to build a
