Minutes of Commission meeting held on August 3, 2004.

7:05 p.m. Chairperson called the meeting to order.

7:10 p.m. Minutes of Commission Meeting held on July 27, 2004, were read. Motion made by Steven Anderstrom to accept the minutes as read seconded by Helen Kreiger and accepted by all.

7:15 p.m. Debbie Tierney, Notary Public, notarized Conservation Commission Member signatures affixed to the Order of Conditions for Andre Romano and Gary Boniface. Order of Conditions to be hand delivered to Steven Bressette of Jalbert Engineering on Wednesday, August 4, 2004.

On 7-29-2004 Steven Bressette submitted 2 Notices of Intent, both were for Elias Hanna, Lot 2, 84 Sturbridge Rd., and Lot 3, 86 Sturbridge Rd., to be posted in The Republican August 2, 2004. The Public Hearing to be held August 10, 2004 at 8:00 p.m. Filing Fees of \$137.50 was submitted for each Notice of Intent.

7:55 p.m. Procedure Sheet #04-813 issued to Francis and Kathy Gregoire of 60 Wales Rd., Map 16-E-10.01 to build a single-family house. Motion to approve project made by James Wettlaufer seconded by Howard Fife and approved by all. Procedure Sheet signed by Steven Anderstrom.

Old Business

On Monday August 2, 2004 Bruce Griffin of New England Environmental Inc. called to say that he and Mr. Thomas Gould would meet with the HCC on Mr. Gould's property at Allen Hill Rd. on Wednesday, August 18, 2004 anytime between the hours of 7:30 a.m. and 5:30 p.m. Mr. Griffin questioned if, in the interim, Mr. Gould could work to stabilize certain areas around the wetlands. He was instructed that no work is to be done until the HCC meets on Tuesday, August 3rd. Mr. Griffin was called on Wednesday, August, 4th and told a site visit is scheduled for 3:00 p.m. on August 18th, and absolutely no work is to be done on the property.

Mark Farrell is to be called on Wednesday, August 4th requesting that he bring in the aquatic plant listing for the Coir Logs for Mr. Robert Scott's project.

The HCC received a letter from Lee Lyman of Lycott Engineering requesting a 3-year extension to the current Order of Conditions, DEP File #184-130 for the continued maintenance of the aquatic vegetation in Hamilton Reservoir with lake-level drawdown. They enclosed a completed WPA Form 7 - Extension Permit for Orders of Conditions. Motion made to approve the extension until September 9, 2007 was made by Steven Anderstrom, seconded by Helen Kreiger and approved by all. Lycott Engineering will be notified that their WPA Form 7 will be revised

reflecting the new form that incorporates the Notary Public language that became required on May 15, 2004.

The HCC received from the DEP, Notification of Wetlands Protection Act File #184-182, project location 84 Sturbridge Rd., (Lot 2) and File # 184-181 project location 86 Sturbridge Rd., (Lot 3).

HCC signatures affixed to Vendor Voucher in the amount of \$44.13 for a Panasonic Recorder (\$39.54) and clasp envelopes (\$4.59) to be submitted to the Treasurer.

Motion to adjourn made by Helen Kreiger, seconded by Art Fusco. Meeting adjourned at 8:30 p.m.
