At the request of Ms. June Rose for permission to remove the silt fence at 13 Leno Road, Brad did a site visitation on 9/18/01. He reported to the HCC that all the area had been grassed and the removal would be O.K. All agreed. Brad called Ms Rose on 9/19/01.
