

Minutes of meeting held on October 9, 2001

Mr. Roy Boire, contractor, came to the HCC to advise us that he has been asked to fill in a wooden retaining wall on property in Union, CT but on Hamilton Reservoir. We suggested that he use rock rather than straight wooden beams. Howie mentioned that the Town of Holland pays taxes to Union for the land under the lake in Union. No further action taken by the Commission.

Public Hearing for Joe Gay opened at 8:45 P.M. Procedure Sheet #01-0390 issued to Joe Gay, 17 Craig Road, Map R-21, Lot C-3, to replace septic system and drill new well. Presented by Mark. All approved and signed a negative Determination of Applicability. Copy sent certified mail to Mr. Gay and copies sent to DEP and Mark on 10/10/01. Public Hearing closed at 8:59 P.M.

Public Hearing for Richard Asselin opened at 9:00 P.M. Procedure Sheet # 01-0389 issued to Richard Asselin, 15 Craig Road, Map R-21, Lot C-2, to replace septic system, drill new well and build driveway. Plans were presented by Mark. All approved and signed a negative Determination of Applicability. Copy sent certified mail to Mr. Asselin and copies sent to DEP and Mark on 10/10/01. Hearing closed at 9:10 P.M.


Check for \$60.00 received from Mark covering legal notices on the above 3 hearings
