Minutes of Holland Conservation Commission (HCC) held on June 14, 2016.

Meeting called to order at 6:37 by Chair M. Beal.

Motion by J. Chaffee, 2nd J. Crowley to waive reading of minutes of May 24 2016 and accept with amendments.

- New Business: "Capital Vision LLC" was not the contractor-it was the "name". No reply to HCC inquiry as yet.
- Old Business: "sit" s/b "site".

Announcements:

- HCC was awarded a \$700 increase for the 2017 budget.
- Per contact with Mr. Pucci concerning wall repair...will not continue on repair until the fall.
- A down-spout was observed coming out of a home and ending in the lake has been removed. Owner said it was to keep his rain barrel from freezing during the winter.
- In reply to request for beach usage at Lake Siog...Army Corp of Engineers must be contacted.
- \$326 allotted from 2016 HCC budget to purchase two new chairs. Chairs forthcoming.
- LOC has requested a representative from HCC attend meetings. C. McCooe will represent both HRA and HCC.
- J. Chaffee: took photos of trash accumulating in the water by the main causeway. Sent an email to Highway Dept. B. Johnson. Waiting for reply as to how this area can be cleaned.
- J. Crowley: commented on missing tree bark on a tree at the Mashapaug property owned by LeMountain. Will follow through on why this was done.

Mr. Patten had been issued an Enforcement Order and request by HCC to attend meeting to explain the cutting of his acreage with no Notice of Intent or cutting plan authorization. He did not realize he needed one either. He said - though he was one of three partners in the business - he has been living in Maine these past three years. He stated that his partners had cut the trees to be used as a fuel source for the stove that heated the 3-bay working garage. (He was informed by Mark Stinson that legally he could cut up to 10 cords a year with no permit.)

His two partners have left and at this time OBAR Inc. is in Chapters 7 and 11. Mr. Patten has no plans to expand this business but he will be working closely with it.

In reference to the culvert, it was there when he bought the property.

The "Drop Yard" will continue to be used and Adler will continue to use a portion of the property to store their clean-up dumpster. When used, they are properly cleaned prior to storage at 487 Mashapaug Rd.
