Old Business

Senior Van. We did not have enough information to prepare a warrant for this year. We could possibly get a rider on the Senior Housing grant. If the van can be a green vehicle (hybrid or electric) there is a possibility of a grant. The National Safety Council has courses to train drivers on safe wheelchair loading.

The Senior Housing Committee is working with Chris Dumphy of the Pioneer Valley Planning Commission. Chris has submitted a proposal for a grant to conduct the Senior Housing Study.

The Senior Survey results have been tabulated. There were 175 responses out of 560 surveys sent out. Next step is to compile a confidential list of residents in need of services and what they might need in case of emergency.

Newsletter - advertising payments have not been received from three of the advertisers.

A warrant was submitted to the town to increase the Senior Tax Work Off maximum payment amount to \$1200.00 a year.

Liability waivers for exercise classes will be developed. Paula will ask the YMCA for assistance in the wording of the waivers.

Emergency closings will be posted on Channel 3, Channel 40, and Fox. The closing policy and posting information will be added to the Newsletter.

The Holland Elementary School principal would like seniors to be pen pals with the Fourth Grade students. Paula will ask the seniors to volunteer.
