Dori shared info about a conversation with Janine and Stacy regarding LOC responsibilities:

Janine shared her view with Dori that LOC is only responsible for the water in the Lake. The town is responsible for the dirt, land and the land under the Reservoir. Dori shared her disagreement with this statement. Chris shared related info: LOC Mission Statement – Health and Safety of the Lake and to report back when things need to be done. Dori added that LOC is not only responsible for the water, but how it is used, including Dock and Boating Rules and reviewing safety issues with Police as necessary.

Janine called Chris about issue with the effectiveness of the draw down and shared complaint that BOS was receiving calls complaining about the water initially being to low and now being too high. Chris explained this is not an LOC issue. The BOS is the applicant for the drawn down. Complaints should be directed to the BOS. That said, we hope to discuss ways to improve the process at upcoming Joint Meeting. Chris and Dori have also received calls with resident's dissatisfaction with the process.

LOC has been contacted by several residents, on North and South Basin, with issues related to Flooding. BOS has been slow to make contact with residents looking for information. Highway Department is unreachable as mailbox continues to be full and is not accepting messages.

Chris raised concerns that maintenance needed on the culverts near the Dam has not been completed by the highway department. Debris and weeds have not yet been cleared.

- Vote on A. Johnson's replacement on LOC to be sent to BOS
 - Clarification: In previous meeting we voted that Dori would replace Allen. However, we still need to fill the opening left by Dori. We are still seeking candidates. Further discussion will be tabled until next meeting.
