- Sam asked Brian to provide the report; Brian said he would try. Sam will ask Joanne admin for Highway for report
- o What is status of Letter of Interest? Chris will follow up with Jay on status.

- Sam explained a different approach for improving water flow at the causeway. Rather
 than just expand the size of the culvert it might make more sense to install a bridge.
 This might be achieved by installing a Prefab bridge. It could be built offsite and
 "dropped in place" with reduced traffic interruption.
- Chris asked who the Engineering company was. Sam suggested Google: Uxbridge bridge replacement.
- BOS 2020 5 BOS Rep to LOC. It was not discussed at tonight's BOS Meeting. Lynn to send communication form due by next meeting. Hoping BOS can put on their agenda for the 10/20 meeting.
- Feasibility Study what is LOC/BOS plan how does LOC want to proceed
 - Highway 2008 Reports rec'd 2015 others coming? Already discussed above
 - o Culvert Causeway Sub-Committee Sam No report. Doug is willing to join this group
 - Catch Basin & Dam Brush Cleaning Sam to follow up with Conservation Committee about receipt of Catch Basin Reports.

New Business:

- BOS review Chris met with BOS on 10/6 just before LOC meeting
 - Informed them that Phragmites at the Dam can't be treated now too late –
 Solitude will charge approx \$975 can't do now too late but next year.
 - Brian plans on doing landscaping at Dam in couple of weeks he's aware of the Phragmites –they really shouldn't be cut – that spreads the seeds downstream.
 Can we use Norcross donation or Dam Maintenance to treat?
 - Chris gave BOS a quick lesson on HR Invasive weeds: Milfoil in mid June,
 Fanwort & Tapegrass in August, watershield late Aug or early Sept & showed them pictures
 - Explain Sam and Tom as contacts for weed treatment warnings –
 - Asked them to mark their calendar for RFQ for Lake Maintenance should be written and submitted by March 2022 – found another contractor The Pond & Lake Connection
 - Draw Down protocol form from Brian haven't seen it, Bettina will check with him.
 - ProcellaCor justification Gave them information on new Chemical they agreed to put on STM warrant under LOC recommendation asking for \$3140 to treat Milfoil in Union
- Sam has volunteered to be LOC liaison to communicate with BOS Town Admin Janine: <u>townadmin@hollandm.org</u> & <u>ofba.permits@state.ma.us</u> (Bret Sherry) regarding weed treatment notices & dates
- Con Com Agent LOC will provide support letter for petition for Town Meeting
 - So many calls for tree removal and construction along the waterfront, repairing and enlarging homes. Need someone who can follow up on details and projects. Follow on phone messages
 - Position will report to conservation

- o Part time position (15 to 20 hours.)
- Chris made a motion to create a Letter of Support for the Conservation Agent.
