

Minutes Tuesday, April 20, 2021 Select Board Meeting – 5:00PM VIRTUAL MEETING

Meeting Opened at 5:00PM by Chair, Bettina Schmidt

Reading of Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place.

1. Minutes from 4/6/21

- Motion to approve as written made by Mr. Johnson; 2nd by Ms. Schmidt
- Ms. Schmidt Yes, Mr. Johnson Yes

2. Police request to discuss Cruiser Trade-In and Firearms trade in

- a. Firearms
 - i. PD requesting to trade in 15 firearms that are out of date and in poor condition
 - ii. Company PD goes through for firearms is offering \$3000 credit for trade-in toward purchase of remaining 6 firearms needed for every officer to have same make/model/caliber of handgun (cost is just under \$500/each)

Motion: Mr. Johnson made a motion to support the PD request to trade in old firearms and use credit to purchase 6 new firearms to equip each officer with same make/model/caliber of handgun

b. Cruiser

- i. Article for Funds to purchase new police cruiser approved at Special Town Meeting (STM) Nov 2021
- ii. Will be taking a cruiser (2011, approx. \$90,000 miles) out of commission; request is to use that money toward equipping new cruiser

 - ii. Discussion on one-way traffic and using front door for entering and door at Police Department side of building for exiting
 - iii. Limit public access to certain areas
 - iv. Consider opening parttime certain days/hours to start
- b. Ms. Schmidt to reach out to Sturbridge Town Hall to see how they are handling things
- c. Ms. Stout to contact Brimfield and Wales
