Anthony Wonseski Jr., P.E. Senior Engineer, SVE Engineering, 377 Main St., Greenfield, MA. (413-774-6698 x 28) representing Town of Holland made some minor revisions to the original plan. He discussed the proposal for new drainage piping including eight new catch basins to be installed. Per Brian Johnson (Highway Department) catch basins are cleaned twice a year. How many feet of lakefront would be subjected to the new drainage pipe; which 12 trees/shrubs would be removed and replacement locations. He stated the standard approximately 13' of lakefront would be touched during the project where as the standard footage is up to 50'. Well below the standard will be involved.

Sediment run off in lake and on homeowner's property has significantly increased. Per one home owner, Mr. Joseph Whitehead, the water depth at his dock was originally 10'. Within the las 8 years the depth has decreased to 5' due to sediment run off and build up.

\$157,000 funding coming from a grant. Highway will probably need more money than grant. Project will go out to bid during the winter (2015-2016) and permits will be submitted and accepted for the project to commence in the spring of 2016. Additional sources of funding will be considered.
