Applicants and all were in favor of closing the hearing at 8:10 p.m. Steven Brissette is to be notified by phone when Order of Conditions are completed.

8:30 p.m. Andre Cormier of Escape Estates presented us with a new map of Mashapaug Estates but again Lots 9 and 12 were not depicted. Mr. Cormier promised an updated map. The Public Hearing for March 15, 2005 will need to be postponed to a later date allowing for a Legal Ad to be printed and posted in The Republican.

9:00 p.m. We received from the DEP a copy of a letter sent to Diana and Kenneth Denning of 90 Union Rd., stating that "the Department is concerned that filling and grading of soil has occurred in close proximity to a pond and bordering Vegetated Wetland without having first obtained an Order of Conditions from the Holland Conservation Commission. The Department would like to arrange an inspection in the near future." We are waiting to hear from the DEP on this matter.

9:15 p.m. We continued to discuss the New England Land and Lumber map and project. James Wettlaufer made a motion that a letter be sent to them requesting an updated A-3 map and a current abutter's list prior to arranging a public hearing. Howard Fife will also call. Motion seconded and accepted by all.

Motion to adjourn made by Steven Anderstrom, seconded and approved by all. Meeting adjourned at 9:40 p.m.
