The Notice of Intent of Tina and Scott Rootes-Hunter was assigned the following file No. 184-160 by the DEP, states that adequate erosion and sedimentation controls are required for projects of this nature – the DEP Storm Management Policy must be complied with. The Order of Conditions will be sent to Tina and Scott Rootes-Hunter on Wednesday, October 21, 2003 with those conditions stated.
