## Minutes of meeting held on June 11, 2002

Meeting opened at 7:00 p.m.

The following people from Lakeshore Drive joined the meeting, Agnes Gallerani, Carol Anderson, John Anderson, Martha Tabb and Jerry Tabb.

They, among others, have deeded rights to use the right of way that abuts the property of Mr. Molin. At the spring meeting of the Hamilton Reservoir Association, a complaint was filed with Brad and Helen about the angle that Mr. Molin had placed his dock. On October 16, 2001, the Conservation Commission reviewed a procedure sheet from Mr. Molin to rebuild a porch and roof. At the same time a drawing was presented which included the location of a new dock. The Commission crossed out the indicated angle and drew in our approved direction. This drawing was stamped by the HCC as approved. Prior to tonight's meeting, Mary did a site visitation and took a picture, which indicates that the dock is angled so that the dock goes over the extended lot line of Mr. Molin. After Mary brought everyone up to date on what the Commission has done on this complaint, the group made their presentation. Many pictures were presented and a map showing other docks that other lot owners have placed their docks within their property lines. One of the group felt that Mr. Molin has been trying to do things to the property according to all the rules and regulations and would change the angle of the dock. Others had different opinions. Jim related other dock problems that were brought to the Selectmen and their outcome. He suggested that this problem be settled without going to the Selectmen. Brad to write Mr. Molin to see if he will re-angle his dock as shown on the approved plan. As the HCC approved the suggested the angle of the dock, we feel that we should try and resolve the problem.
