Minutes of meeting held on May 14, 2002

Meeting opened at 7:15 p.m.

Jim was voted in as acting Chairman in Mary's absence

Minutes of May 6 read and approved. Signed by Jim.

Brad reported on various items:

- 1. Letter written to Mr. Picard regarding the beavers on his property.
- 2. Letter written to Mr. Beyor regarding his run off problem.
- 3. According to Earl Johnson, our request to name the land given to the HCC will be placed on the Town Meeting for approval by the town. Makes it permanent.
- 4. Letter written to Mr. Brunner regarding run off down Kimball Hill Road.
- 5. Documents received from Robin Weckesser regarding building lot on Lois Land were discussed. The Determination of Applicability signed on August 25, 1986 expired 3 years later. Brad to call Ms Weckesser and explain the problem.
- 6. A revised land plan of the Sichol property was received and filed

Procedure Sheet 02-0484 issued to Rolf Hilbig, 46 Island Road, Map R42, Lot B-54, to strip and re-shingle house and garage. After noting that a dump trailer to be on site and loaded daily, all approved and signed by Jim.

Procedure Sheet 02-0489 issued to Roy Walker, 97 Sandy Beach Road, Map R39, Lot F-6, to repair septic system and an addition to house. A Notice of Intent was also received and a Public Hearing was set for 6/4/02 at 8:00 p.m. Also received were checks in the amounts of \$25.00 (legal ad) and \$67.50 (filing fee) that were given to the Treasurer on 5/15/02. Legal notice faxed to the Union News on 5/15/02.

Mr. Beyor joined the meeting with his attorney Mr. Raymond Blanchette to discuss the letter we sent to him. It was agreed that Mr. Beyor did not cause the run off that is running through the building site. It was agreed to by the HCC and Mr. Beyor that he would run hay bales or a silt fence to stop the erosion of soil to the South of the well. It is hoped that the water flow will be slowed and eventually stopped by grading and planting.

Received a copy of Procedure Sheet 01-0353 issued to Steve Beyor on 8/21/01 for new home construction on lot 8, Leno Road, Map 8, Lot A-2 No action taken as this was not an official submission.

The Public Hearing for Ernest Riley opened at 8:15 p.m. There were no abutters at the Hearing. Mr Riley presented his plans to the HCC. We noted on the Order of Conditions that a collection system to contain gray sludge from the well drilling be in place and that Staked hay bales be in place prior to any excavation. All members present signed the Order of Conditions. Mailed to Mr. Riley (certified) and to D.E.P. and Para on 5/15/02. Hearing closed at 8:30 p.m.
