Received vernal pool certification form from the Division of Fisheries & Wild life. Pool # 2545 is on the Benjamin Haller property off Dug Hill Road. Certificate on file with the HCC.

Ms Carolyn Reardon submitted WPA Form 8A - Request for Certificate of Compliance regarding a home at 16 Vinton Road. Order of Conditions (supplied by Ms Reardon) was issued to Paul Maguire Sr. to build a home on Lot 2B, Map 5, on 9/19/87. DEP File Number 184-29. Mr. R. Sohlgren, abutter to Muirfield project on Maybrook Road, addressed the HCC complaining that more cutting was done than was authorized. The buffer trees that were suppose to stay have been removed. We explained that a stop work order, except for the road off of Union road for drilling of a well, has been placed on this project. We can not order the trees be replaced at this time. When the final plans and all permits have been issued, we will issue an order of conditions which can include replacement of, or

planting of, buffer trees. Mr. Sohlgren felt that someone from the town should be overseeing this project on a daily basis. We responded that the abutters have been doing just that and they have appeared before the HCC on numerous occasions. Members that have not visited the site lately will do so. As the property is posted, a roadside viewing will be necessary.

It was brought to the attention of the HCC that the work being done under Procedure Sheet #01-0291 issued to Jimmie Craycraft to do, among other things, replace a retaining wall, may not be in accordance with our agreement with Mr. Craycraft. Brad to write a letter reminding him of our agreement.
