7:15 PM— Public Meeting—Review of Forest Cutting Plan Todd Montgomery/65 Allen Hill Road

Public Meeting Opened at 8:43 pm

Persons in Attendance: Kathy McKenna; Marcia Beal; Kaitlin Laabs; Sam Spratlin; Dawn Kamay

- **Discussion:** Members reviewed the updated plan and the Christmas Tree Farm has been scaled back considerably. Kaitlin made a site visit on Saturday 2/8/2020. She noted that the newly proposed project is well away from the wetlands— approximately 400-500 feet. The Vernal Pool on the map is 100 feet and on the other side of the road from the property. Kaitlin did not feel that a RDA was necessary since the newly proposed site for the Christmas Tree Farm was outside of ConCom's jurisdiction.
- Motion: Sam moved that we accept Kaitlin's recommendation to allow this project to move forward without a RDA as it appears to be outside of Conservation's jurisdiction. Marcia seconded. All in favor; motion passed.
- **Decision:** Allow DCR to continue to manage the forest cutting plan. Kaitlin will email DCR and the Licensed Forester, Kevin Scherer with this information.
- Kathy made a motion to close the public meeting. Dawn seconded. All in favor; motion passed.

Kathy McKenna for Steve Bressette/Project Engineer: Kathy submitted 2 NOIs that were hand delivered to her by Steve Bressette. Steve has mailed copies of these NOIs to the DEP with payment. Steve has abutters' notices ready to be mailed out when ConCom receives official notification of the NOI numbers from DEP and sets times for the Public Hearings. ConCom will be responsible to place the Public Notice in the Newspaper. Steve submitted checks for the Holland Portion of the fees for both projects. Steve would like these NOIs to be addressed on the same evening—if at all possible. He noted that the properties are next to each other. Both are for garage additions to existing homes. Commissioners may try to make a site visit to get an initial understanding of these projects and their locations.
