Retaining Wall

Additional Persons Attending Remotely: Homeowner, Rebecca Osleger

Discussion: Want to build two new retaining walls, one 60ft wide and one 80ft wide. The 60ft wall will be 40 feet from the water, the 60ft wall will be 10 ft further in. Walls will be about 7ft high. Will be hand dug and built by hand. George conducted a site visit and the slope is 15%, he has concerns about the project. He would like more information regarding how he will be handling fill, how much fill is being removed, materials being used, etc. Kate feels that this project warrants an NOI, Jess is afraid that if we push that decision off until we gather more information the project will be pushed off an unreasonable amount. Dawn and Marcia concurred that the scale of this project warrants an NOI.
