There was a discussion of what is acceptable to determine locations of flood plain; FEMA, established benchmarks, or GIS. We have been using the town's GIS system. This will be pursued further, and Jessica Wales has asked the DEP to assist the Commission with this question.

7:00 PM – The RDA for 38 Williams Road continuance with the applicant Jeff Jones present. The project, invoilving the replacement of existing Sono tubes/piers was discussed and the public meeting closed at 7:10 PM. Dawn Kamay made a motion to accept the replacement of up to 12 piers under the existing house, Marcia Beal seconded and all approved.

DEP #184-0357 – Zielinsky at 50 Stony Hill Road - The OOC extension - Dawn Kamay made a motion to grant the request for an extension. Marcia Beal seconded and all approved.

Michele Bouchard's nomination to the Commission was approved by the Holland Selectboard and the Town Administrator will notify her of this and tell her what next steps are required, such as swearing in. The Commission has agreed to nominate Rick Lundin to the Selectboard as our 7th member. Dawn Kamay will send the letter/nomination.

- 1.0 <u>Items from last meeting or new non-application items that need action/discussion:</u>
 - 1.1. There is a real typewriter in the Commission office, do you want to hold onto it for any reason?
 - 1.2. I have started work on the history of permitting with the Highway Dept. When you get the report, you will notice that there is a lot of missing information. As I dig more into the projects, the spreadsheet will be occasionally modified. I expect to send out the report before the 25th.
 - 1.3. I have previously forwarded e-mails from the residents on Brandon and Brian's response. If you wish to discuss this issue, please bring them to the meeting.

2.0 <u>Items on this agenda:</u>

- 2.1. <u>29 Pine Tree, NOI:</u> This permit was filed as a result of a complaint and a subsequent SWO/NOV that was issued. The permit is for work that has been completed and includes, among other things, new drainage, patio, retaining walls and decking. One of the issues that concerns me is the drainage which is shown in the attached photo. We do not know exactly what this is draining, but we do know that the drainage appears to be negatively impacting the adjoining property. I would recommend that the plans be modified to better channel this drainage so that any discharge/run-off remains on-site. I also recommend that the plans be labeled and dated so they can be referenced in the OOC. Further, all work is taking place in a flood hazard zone and no quantities of material or disturbance were submitted. When the revised plans come in and are acted upon by the Commission, I will make recommendations on conditions.
- 2.2. <u>38 Williams, RDA/COC:</u> This work was discussed with the Commission at their last meeting and consists of the replacement of 12 sono-tubes. I would recommend a negative #2.

- 2.3. <u>50 Stony Hill Request for an extension:</u> This permit is set to expire next month and the applicant has requested a three-year extension. I see no reason why the extension should not be granted.
