- 6) General Liability Insurance / "Hold Harmless"
 - a) Any vendor that has a Commercial General Liability policy is to show proof of general liability coverage with Town of Holland as additionally insured. The certificate must be presented upon set up of display.
 - b) Any vendor that does not carry commercial general liability insurance-INDEMNITY AGAINST GENERAL CLAIMS. I hereby agree to indemnify, defend and save hold harmless the Town of Holland, its officers, directors, employees, and volunteers from and against, and to reimburse the Indemnified party with respect to, any and all claims, demands, causes for action, losses, damages, liabilities, costs and expenses (including reasonable attorneys fees and expenses, court costs and costs appeals) asserted against or incurred by the Indemnified Party by reason of or arising out of the display or sale of items by the undersigned on the premises of the Town of Holland. This agreement shall be binding on the parties hereto, their successors and assigns.
