At approximately 9PM, Ron made a motion on a determination/finding by the ZBA regarding Mindy Wills' request to allow a Tier 1 Marijuana growing facility in the basement at 18 Craig Road as a home business being approximately 400 sq.ft. and not exceeding 543 sq.ft. The motion stated: "I move that the ZBA reject the proposal because the growing site is approximately 270 feet from the Holland Elementary School, which is well within the 500 foot buffer zone required by the State of Massachusetts.

Allowing this activity would violate State Law and make the property more detrimental to the neighborhood".

Don seconded the motion. The Board discussed the motion. John asked that the last sentence be re-read again, and more discussion. The Board voted on the motion. All members voted yes on the motion. Motion passed.
