HCC Director Brenda Palmer, updated the FB with detailed information of all the roles she plays as the director of the HCC and how the community and its residents is being served in the Town of Holland. She has done intensive research in comparing other community centers in surrounding towns and the programs being offered for those communities as well as how the directors are being compensated. From her findings she is requesting an increase in her salary for FY25 to be more comparable with other towns; she is also requesting for the COA budget for FY25 to be decreased as other funds are available to the center through different grants. In order to receive a van donation, she requested that the van remain a line item in the FY25 HCC budget to cover the cost of expenses and staff wages for the senior transportation program.
