- 3. Town Accountant Report: (L. Bartkus) will schedule for another date.
- 4. Fire Department Report: (J. Gagne) presented the details of the Fire Dept.'s request for FY25 budget which includes a 3% COLA increase for all positions and an increase to minimum wage for all firefighters. Department expenses were increased to cover the cost for the now required OSHA physical screening for all fire fighters.
- 5. Board of Assessor's Report: Cynthia Poirier Board of Assessors Chair, and Priscilla Clowes Principal Assessor, presented the FY25 Budget for the Assessor's department which include expense increase for various certifications, new vendor fees, 5y DOR re-evaluation and a 3% COLA increase. Priscilla indicated that, after finding a software error, the New Growth figure used in calculating the Levy Limit could be increased from \$50K to \$56K.
