## **Approval of Minutes**

**Motion 121917-1**, Mr. Mandell to approve the minutes of December 5, 2017 as written, 2<sup>nd</sup> Mr Gillen. So voted.

#### **Old Business:**

### Hiring of Town Counsel

**Motion 121917-2,** Mr. Gillen, to hire attorneys for town work per diem for the remainder of the fiscal year as a trial period. 2<sup>nd</sup> Mr. Mandell.

Discussion on how to pursue who should be hired for each job. Ms. Schmidt stated there should not be a problem calling a meeting to vote on the chosen attorney at short notice. Mr. Mandell stated that he saw no problem with delegating the authority to choose to the Chair. Mr. Gillen expressed discomfort with that delegation. Ms. Robbins explained how select board members of past boards had used town counsel as their own law dictionary and to pursue personal inquiries costing the town a lot of money.

Ms. Schmidt called for the vote on Mr. Gillen's motion. So voted

# Police Chief Contract

The Police Chief has been working under an automatic one year renewal of his contract for FY18. The new contract, to take effect July 1, 2018 and run through June 30, 2021 was distributed between the Select Board and the Chief for review.

Ms. Schmidt asked if anyone had any questions or objections to the contract as written. Hearing none Ms. Schmidt called for a motion.

**Motion 121917** – Mr. Gillen, to sign the Police Chief contract as written. 2<sup>nd</sup> Mr. Mandell. So voted.

Contract signed by full Board.

#### Probation/Contract with Fire Chief

Ms. Schmidt stated that this topic was on the agenda at the request of Mr. Gillen. Mr. Gillen was not present for the meeting where the Fire Chief probationary period was extended for another 120 days.

Ms. Schmidt stated there have been complaints received regarding Chief Gagne and recommended extending the probationary period for an additional 120 days until more information is known regarding the complaints received.

Mr. Gillen stated he was fine with those results but wanted it on the agenda so he could inquire where they were with possible contract discussion.
